3. ELIZABETH WARNER PITTS³ SHERBURNE (*JOHN NATHANIEL², NATHANIEL¹*) was born March 17, 1823, and died October 12, 1909. She married PEARCE WENTWORTH PENHALLOW October 16, 1845 in St. John's Chapel, Portsmouth, NH, son of HUNKING PENHALLOW and HARRIET PEARCE. The couple assumes title to the Warner House in 1860 after buying out her five siblings listed above.
